The paper states that 52 certified samples were tested, of which 88 per cent were FSC and 14 per cent PEFC, implying 44 FSC samples and 8 PEFC samples. The paper also says 46% of those 52 samples were found to have incorrect origin claims, implying 24 false origin certified samples; even if all 8 PEFC samples were false origin, this would still leave a minimum of 16 false origin FSC samples (36 per cent of the 44 FSC samples). The maximum FSC false origin rate is 55 per cent.
